

## Keeping Cool in Summer (South Australia)

### Barastoc Poultry Summer Consumer Promotion

#### Terms and Conditions

The promoter is Ridley AgriProducts Pty Ltd ABN 94 006 544 145 (hereafter referred to as either **Ridley** or the **Promoter**). The promotion will be conducted in South Australia. Barastoc is a registered trademark of Ridley; whose address and telephone number appears below.

#### Method of Entry

- Entry forms will be made available to participating resellers. Consumers will be informed of this offer through Barastoc Poultry branded in-store merchandising communication, which may include posters and counter cards as well as through digital and social media channels.
- At the time of purchasing any Barastoc Poultry 20kg product from participating stores during the promotion period, the consumer will be offered an entry form. Consumers will enter their name and contact details and attach a copy of proof of purchase to enter the draw. Each week the store will conduct a prize draw of 5 winners of Barastoc Poultry prize packs each. The store's competition period will conclude once they have exhausted their prize packs.
- Winners will be determined by barrel draw on selected dates, listed in Promotional Timings.

#### Terms and Conditions of Entry

- Information on Method of Entry, Promotional Timing and Prize Pool Details form part of these Terms and Conditions. By participating in the Keeping Cool in Summer promotion, eligible entrants are deemed to have accepted these Terms and Conditions.
- The promotion is open to all Australian residents excluding those in the Australian Capital Territory, Northern Territory and Western Australia who purchase a minimum of any 1 x 20kg bag Barastoc Poultry feed in a single transaction from participating stockists. This expressly excludes the Promoters' employees, contractors and their immediate families and participating retail stockists' employees, contractors and their immediate families and any person who has breached the Terms and Conditions of any promotion run by or on behalf of Ridley.
- Verification Requirements: The Promoter may require the entrant to provide proof of identity, age, and residency.
